Dear Shareholder,

We are pleased to present you the following semi-annual report for the ESPA STOCK ASIA INFRASTRUCTURE mutual fund pursuant to InvFG for the period from 1 June 2011 to 30 November 2011.

We would also like to inform you that the calculation of the value for ESPA STOCK ASIA INFRASTRUCTURE was suspended for one day because there was one non-trading day on the Hong Kong Stock Exchange on 30 September 2011.

Development of the Fund

The fund invests in sectors that truly represent Asia's infrastructure or are necessary for its improvement and further expansion. These include the following: utilities, traffic and transport, construction companies and conglomerates, telecommunications, environmental infrastructure and raw material infrastructure. As a result of rapid economic growth in recent years and lapses in development over the past decades, countries such as China and India have a lot of ground to make up when it comes to their motorways, railway lines, power plants, supply of energy sources, ports, airports, sewage plants, water supply, etc. Governments and economic decision-makers are well aware of this problem, so additional billions of dollars in investments are slated for the years ahead. In addition, there are plans to create incentives for private investments to support these developments. The companies in which the fund invests should profit from this.

The debt crisis in the developed countries, volatile commodity markets, inflation in the emerging markets and the global economic downturn have put a damper on investor sentiment in recent months. Following a sideways trend in the summer, the equity markets saw their first dramatic decline in August. A second downward movement followed in September, which was then interrupted by positive trends until the end of November. Despite the worsening of margins, corporate results were positive. Although the economic data were recently somewhat weaker, they remained at a profitable level in Asia. Economic growth for the third quarter came in at 9.1% in China and 6.5% in India. Indonesia posted 6.5% growth and Malaysia saw an increase of 5.8%.

As is shown by the development of earnings in the infrastructure sectors, the structural developments in Asia are intact. However, several sub-sectors, such as transport, are more exposed to economic fluctuations. Due to global and local topics such as inflation and monetary policy, volatility has increased once again on the stock exchanges.

The largest sector weighting in the fund was construction (including shipbuilding and railway construction), followed by utilities. Chinese equities comprise the largest share of the portfolio. The portfolio's PER is currently 11 based on the profits for next year, and its dividend yield amounts to 2.5%.

Outlook

Asian infrastructure equities offer good prospects; the Asian governments have also identified this sector as a target for improvement measures. Conditions on the capital markets have developed positively. As a result, profitable companies now have easier access to equity and borrowed capital and are also better able to take advantage of their growth opportunities. Many countries continue to offer subsidies (financing subsidies, government aid, etc.). This is plain to see in China and India's long-term economic plans. Large investments are being made in areas ranging from road construction in India to the gas and water supply in China. Earnings for the emerging Asia region are estimated to increase by 13.5% in 2012. Equities currently have favourable valuations, and the Asian market as a whole is valued at a price-to-book ratio of around 1.5. This is below the long-term average, so it offers investors good prospects over the medium and long term. If the economy develops well and corporate results are positive, we can expect a great deal of upside potential.
