Dear Shareholder,

We are pleased to present you the following semi-annual report for the ESPA STOCK EUROPE-EMERGING mutual fund pursuant to InvFG for the period from 1 June 2011 to 30 November 2011.

Development of the Fund

Due to the sovereign debt crisis in Europe, economic growth in the emerging Europe region has slowed somewhat in recent months, particularly in the export-dependent countries of the Czech Republic and Hungary. The IMF expects 4.3% growth for the region as a whole in 2011 and 2.7% in 2012, following 4.6% growth in 2010. Economic growth in the Czech Republic fell from 2.2% p.a. in Q2 2011 to just 1.5% p.a. in Q3. In Hungary, growth slowed from 2.5% p.a. in Q1 and 1.5% p.a. in Q2 to 1.4% p.a. in Q3. The leading economic indicators, such as the purchasing managers indices, predict that the weak growth in Hungary will persist in the fourth quarter as well and that there will even be the risk of a recession in 2012.

The Polish economy, in contrast, is profiting from strong growth in retail sales and infrastructure investments for the EURO 2012. Economic growth came in at a high level of just over 4% p.a. in Q2 and Q3 2011, and we are relatively optimistic about 2012 as well. The Turkish economy also delivered impressive performance in recent months thanks to its resistance and growing local demand. The economy grew more quickly than expected in Q3, coming in at 8.2% p.a., which was just slightly weaker than Q2, at 8.8% p.a. However, the leading indicators and the tightening of the Turkish central bank's money market policy due to high inflation and a weak currency point to a dramatic decline in growth in the coming months.

Relatively stable oil prices, higher retail sales and a successful harvest caused economic growth in Russia to rise from 3.4% p.a. in Q2 to 4.8% p.a. in Q3. Nevertheless, the leading indicators in Russia also point towards weaker growth. The extent of this slowdown will depend greatly on the development of oil prices in the coming year. Risk aversion among investors led to a strong depreciation of some of the emerging Europe currencies in recent months. Since 1 June 2011, TRY has lost 17% against EUR, while PLN has dropped 15%, HUF 9%, RUB 4% and CZK 4% (as of 14 December).

The weakness of the emerging Europe currencies led to an increase in import prices, which was reflected in higher inflation. Inflation posed a serious problem particularly in Turkey (9.5% p.a. in November), but it also increased in Hungary (4.3% p.a.) and Poland (4.8% p.a.). This creates difficulties for the central banks because high inflation rates make it hard for them to cut interest rates, which would be necessary to boost the economy. In Hungary, there was even a 0.5% interest rate hike to 6.5% in order to support the currency and stem inflation. Interest rates remained unchanged in Poland, the Czech Republic and Russia, while the Turkish central bank officially lowered interest rates, but at the same time ultimately increased the cost of lending money through various other measures.

According to the IMF, the economies in the developed world will grow more slowly in 2011 than in 2010 (2010: 3.1%, 2011: 1.6%). The developed countries are also likely to see just slight growth in 2012 due to the crisis in Europe and the global trend towards debt reduction. We can assume that the inflation rates will decrease in 2012, allowing for a more expansive monetary policy, which in turn could have a positive impact on the equity markets. Despite the global downturn, the emerging markets are likely to continue to drive global economic growth in 2012. Overall, conditions were negative for equities in recent months. The price losses on the stock exchanges were the result of the intensification of the sovereign debt crisis in the Eurozone (especially in Italy and Greece) and fears of a slowdown in growth in Asia (China). In the reporting period from 1 June to 30 November 2011, the value of the fund ESPA STOCK EUROPE-EMERGING fell by 19.38%. This means that it outperformed the benchmark (BM -20.26%) by 0.88%. Russia (RTSI\$ Index: -12.13%) outperformed the MSCI Emerging Europe Index. Hungarian equities underperformed the market by a wide margin (BUX Index: -33.67%). The strongest performers over the past six months were companies from the gas sector. Steel companies, coal producers and banks were weaker than the market as a whole.
