Dear Shareholder,

We are pleased to present you the following semi-annual report for the ESPA STOCK JAPAN mutual fund pursuant to InvFG for the period from 1 September 2011 to 29 February 2012.

Development of the Fund

Development of the fund

ESPA STOCK JAPAN increased its NAV by roughly 14% in EUR during the reporting period, which reflects the positive trend reversal of Japanese equity indices since last December. In the same period, the appreciation of JPY versus EUR made a positive contribution to NAV.

From September to November of last year, the Japanese market followed a moderate downward trend, influenced on one hand by events in the US such as the rating downgrade, the economic slowdown and the political turbulence due to the raising of the debt ceiling. On the other hand, the deterioration of the situation with the European sovereign debt crisis also had an impact. The consequences on the domestic economy of the earthquake on 11 March 2011 and the resulting disaster at the Fukushima nuclear power plant were difficult to assess and resulted in an unclear market outlook. In addition, the risk aversion of investors towards most financial products contributed to the appreciation of the yen and had a negative influence on the Japanese equity market as a result of the downturn in the development of companies.

In December 2011 and January 2012, however, Japanese equity prices began to increase again due to the apparent recovery of the US economy and the gradual decline in stress on the European financial markets as a result of the LTRO programme by the ECB. Towards the end of the financial year, the upward trend on the market accelerated, driven by the additional loosening of monetary policy and the announcement of the “price stability goal in the medium to long term” by the Bank of Japan.

ESPA STOCK JAPAN's investment policy also uses TOPIX index futures and Nikkei 225 index futures, which were primarily used to control the fund's leverage.

Outlook

The Japanese equity market has been in an upward trend since the beginning of 2012 and reflects the decline in concerns regarding the European sovereign debt problems and the expectations of an economic recovery in the US. However, it will still take a long time to completely resolve the sovereign debt crisis. Because we can see a trend in the equity markets of the larger EU Member States, it is possible that the crisis has already been absorbed and had a noticeable impact on equity market prices.

The introduction of a changed monetary policy with a price stability goal based on the CPI represented a change of policy by the Bank of Japan. This is a positive development for the Japanese equity market, because it indicates a weaker upward trend for the JPY.

However, we should be prepared for a possible corrective reaction on the market following such a strong market recovery since the beginning of the year. In addition, the renewed increase in crude oil prices in combination with the tense diplomatic situation surrounding Iran should be kept in sight because this situation may develop into a global risk factor.
